Neither he nor Glenn Catto can do the fire alarm installation though. Level of fire precaution requirement Fiona reported that Cathcart Ironside & David Beggs from ?Fire Service visited the Hall on Weds (at very short notice) to advise on fire precautions. They left some handwritten notes indicating that a fire alarm system in accordance with BS5839 part 1 L2 is required for occupancy of 100+, but BS5839 part 1 L3 for occupancy of UP TO 100; 'page 85 of the Practical Fire Safety Guidance for Places of Public entertainment& Assembly give accurate figures'
